Réamhrá

Tá ról rathúil ag Údarás na Gaeltachta le 30 bliain anuas i dtreisiú na forbartha agus i dtacú le forbairt teanga, eacnamaíochta agus sóisialta na gceantar Gaeltachta ar fad ina gcuid iarrachtaí lán-acmhainneacht a bhaint amach. Tá obair na heagraíochta fréamhaithe i saol eacnamaíochta, cultúrtha agus sóisialta na Gaeltachta. Ba chóir a aithint go bhfuil thart ar 7,000 duine fostaithe anois i gcuideachtaí a fhaigheann tacaíocht ón Údarás.

Le go mbeidh Gaeltacht rathúil inbhuanaithe ann níor chóir go mbreathnófaí ar an teanga, an eacnamaíocht, an pobal agus an timpeallacht mar nithe comheisiacha. Tá cúramí agus freagrachtaí straitéiseacha uathúla ag Údarás na Gaeltachta don Ghaeltacht agus tá cur chuige comhtháite aige i leith forbairt na Gaeltachta.

Tugann ár múnla oibriúcháin leibhéal ard rochtana dúinn ar thionscail agus fiontair agus ligean dúinn frithghníomhú go sciopta agus go solúbtha do dheiseanna agus dúshláin nua. Lena chois sin, feidhmíonn an tÚdarás mar bhealach do phobail Ghaeltachta, lucht gnó, rialtas áitiúil, eagrais réigiúnacha, oideachais agus taighde, infheisteoirí féideartha agus

fiontair éagsúla lena n-inchur agus comhairle a chur chuig cláir agus polasaithe d'fhorbairt eacnamaíoch, teanga, tionscail agus réigiúnach.

Ciallaíonn an cur chuige seo go bhfuil an tÚdarás in áit láidir le ról ceannaireachta a ghlacadh i bhforbairt na Gaeilge mar theanga phobail agus i bhforbairt chomhtháite eacnamaíochta, shóisialta agus chultúrtha na Gaeltachta. Ag tógáil san áireamh éagsúlacht na gceantar Gaeltachta, a bhfuil buntáistí ar leith ag cuid acu, bónn cur chuige forbartha ar leith ag an Údarás do na ceantair a bhfuil buntáistí aitheanta acu agus dóibh siúd nach bhfuil chomh forbartha sin, na hoileáin san áireamh.

Áit a bhfuil buntáistí ar leith ag ceantair (ar nós bonneagar forbartha agus tionscail, fáil ar réimse leathan seirbhísí, bonneagar turasóireachta, seirbhísí iompair phoiblí nó phriobháidigh, bonneagar fisiciúil agus teileachumarsáide atá résanta dea-fhorbartha) déantar iarracht tógáil orthu seo le breis fostáiochta a ghiniúint agus a bhuanú. I gcás na gceantar nach bhfuil, ar chúiseanna suímh nó eile, na buntáistí seo acu, cuireann an tÚdarás pleannanna sonracha le chéile le haghaidh a thabhairt ar a gcuid riachtanas ar leith. Lena chois sin, déantar gach iarracht barr feabhas a chur ar an acmhainneacht teanga, nádúrtha agus

Foreword

The work of the organisation is rooted in the economic, cultural and social fabric of the Gaeltacht. It should be recognised approximately 7,000 people are now employed in Údarás-assisted enterprises.


In order to have a successful sustainable Gaeltacht the interdependence of language, economy, community and the environment must not be seen as mutually exclusive. Údarás na Gaeltachta has a unique breadth of scale and strategic responsibility for the Gaeltacht and an integrated approach to its development.

Our operating model provides us with a significant degree of access to industry and enterprises and allows us to react quickly and flexibly to new opportunities and challenges. Furthermore, An tÚdarás provides a conduit for input and advice from Gaeltacht communities, businesses, local government, regional, educational, and research organisations,

potential investors, and individual enterprises to programmes and policies for economic, language, industrial, and regional development

This methodology places us in a robust position to take a lead role in the economic, social and cultural development of the Gaeltacht. Taking account of the diversity of Gaeltacht areas, some of which have distinct advantages, we differentiate our development approach between the areas which have recognised advantages and those which are less developed, including the islands.

Where areas have recognised advantages (such as a development and industrial infrastructure, the availability of a wide range of services, a tourism infrastructure, public or private transport services, a reasonably well-developed physical and telecommunications infrastructure), we endeavour to build on these to further generate and sustain employment. In the case of areas which, for locational or other reasons, do not have these advantages, Údarás implements targeted responses to address their specific needs. Additionally every effort is made to optimise the distinctive linguistic, natural and environmental potential of these areas through the adoption of innovative and responsive support mechanisms.



timpeallachta atá ag na ceantair seo trí thacaíochtaí nuálaíocha agus sofotreagracha a chur ar fáil.

Chun pobail láidre teanga a fhobairt teastaíonn cur chuige comhtháite atá bunaithe ar dhea-chleachtas i bpleanáil teanga. Tá páirtnéireachtaí láidre fuinniúla idir phobail áitiúla agus na gníomhaireachtaí ábhartha Stát riachtanach le tógál ar láidreachtaí agus cumas agus cur le líon na gcainteoirí Gaeilge agus le húsáid na Gaeilge mar theanga phobail sa Ghaeltacht.

Teastaíonn earnáil láidir, fhuinniúil fiontair atá ábalta dul san iomaíocht agus é féin a chur in oriúint do gheilleagar domhanda atá ag éiri fíor-iomaíoch chun deiseanna fostáiochta inbhuanaithe a chruthú do phobail Ghaeltachta. Níl Éire iomaíoch níos mó i ndéantúsaiocht bhreisluach íseal, atá ag cailleadh amach d'ionaid íseal-chostas in áiteanna eile. Leanfaidh déantúsaiocht áfach de a bheith ina cuid thábhachtach den earnáil fiontair agus den mbonn fostáiochta sa Ghaeltacht - go háirithe déantúsaiocht nideoige. Cialláinn sé seo go mbeidh straitéis an Údarás ag díriú níos mó ar ghnóthais eolas-bhunaithe agus seirbhís-bhunaithe agus ar fhobairt fiontair dhúchasacha atá fréamhaithe in acmhainní nádúrtha, cultúrtha agus timpeallachta na Gaeltacht.

The development of strong language communities needs a co-ordinated approach based on good-practice in language planning. Vibrant and committed partnerships between local communities and the relevant State agencies are necessary in order to build on the strengths and capacity and increase both the number of Irish speakers and the usage of Irish as a community language in the Gaeltacht.

The creation of sustainable employment opportunities for Gaeltacht communities requires a strong, dynamic enterprise sector capable of competing in and adapting to an increasingly-competitive global economy. We are no longer competitive in low added-value manufacturing, which is being lost to lower-cost locations elsewhere. Nevertheless, manufacturing – especially niche manufacturing is, and will continue to be, an important component of the enterprise sector and the employment base in the Gaeltacht. Therefore, Údarás' strategy will increasingly focus more on knowledge-based and services oriented businesses and on the development of indigenous enterprises rooted in the natural, cultural and environmental resources of the Gaeltacht.

1.0 An Staid Reatha – An Ghaeltacht in 2011

Is údarás uathúil réigiúnach é Údarás na Gaeltachta a bhfuil réimse leathan de ghníomhaiochtaí forbartha idir lámha aige. Tá an Túdarás ag feidhmiú i dtimpeallacht chasta atá ag síor-athrú agus ní mór mar sin a chuid straitéisí a chur in oiriúint don timpeallacht seo ar bhonn leanúnach. Tá gníomhaiochtaí an Údarás dírithe go príomha ar an timpeallacht theangeolaíoch agus shocneacnamaíoch. Tabharfar léargas orthu seo sna haitl a leanas.

1.1 An Ghaeilge mar theanga Phobail

Is í an Ghaeilge fós an phríomhtheanga i roinnt pobail sa Ghaeltacht, cé go bhfuil sé soiléir ó thaighde (An Staidéar Cuimsitheach Teangeolaíoch ar Úsáid na Gaeilge sa Ghaeltacht 2007) go bhfuil brú láidir ar an teanga i bpobail ar fud na Gaeltachta.

Tá todhchaí na teanga mar theanga phobail sa Ghaeltacht idir dhá cheann na meá de thoradh brúnna inmheánacha agus seachtracha. Le blianta beaga anuas tá brú breise tagtha ar an nGaeilge mar theanga phobail de bharr an méadú suntasach i líon na ndaoine nach cainteoirí Gaeilge iad atá ag bogadh chun na Gaeltachta. Tá sé aitheanta go forleathan go gcuireann athruithe mar seo brú ar an méid Gaeilge atá in úsáid sna gréasáin shóisialta sa phobal.

1.0 Current Reality – An Ghaeltacht in 2011

Údarás na Gaeltachta is a unique regional development authority with a wide-ranging brief and set of functions. It operates in a complex and rapidly changing environment to which its strategies and programmes must continuously be adapted. The linguistic and socioeconomic environments encapsulate the primary focus of Údarás activities. Key features of these environments are presented in the following sections.

1.1 Irish as a Community Language

Irish continues to be the main community language in a number of Gaeltacht communities, although it is clear from research (**Comprehensive Linguistic Study of the Use of Irish in the Gaeltacht 2007**) that the threat of language shift is intensifying.

The future of Irish as the community language of the Gaeltacht is finely balanced as a result of a mixture of internal and external pressures. In recent years there has been considerable increased pressure on Irish as the community language due to the significant increase in non-Irish speakers moving to Gaeltacht areas. Such changes tend to exert pressure on the levels of Irish language use in the community and its social networks.

Lena chois sin, tá comhdhéanamh teangeolaíoch roinnt ceantair Ghaeltachta athraithe ó bhonn mar gheall ar a suíomh. Tá siad ag iompú isteach ina mbruachbhailte de bharr a ngiorracht do cheantair uirbeacha atá ag forbairt go tréan. Tá ceantair eile Ghaeltachta faoi bhrú de bharr a dtarraingteach mar ionaid turasóireachta, le lón mór daoine nach bhfuil Gaeilge acu ag cónaí intu go sealadach nó go buan.

I gceantair nach bhfuil réimse leathan den phobal páirteach i ngréasáin ina labhartar Gaeilge, bíonn labhairt na Gaeilge teoranta do na haoisghrápaí is sine agus/nó lucht na n-institiúidí oideachais amháin. I roinnt de na pobail is laige ó thaobh na teanga de tá an t-aon ghréasán labhartha Gaeilge atá fágtha bunaithe ar an oideachas bunscolaíochta. I roinnt eile, nil gréasáin labhartha Gaeilge ag an réimse seo fiú.

Additionally, the linguistic composition of some Gaeltacht areas has been transformed due to their location. Their physical proximity to developing urban centres makes them attractive for suburban settlement. Other Gaeltacht areas are coming under pressure from demographic factors of a similar type due to their attractiveness as tourist destinations, with non-Irish language speakers taking up temporary or permanent residence in these areas of great natural beauty.

In areas where Irish-speaking networks do not include a broad spectrum of the population, the use of Irish is generally limited to the oldest age cohorts and/or educational institutions only. In some of the linguistically weaker communities the only remaining Irish-speaking network is associated with primary school education. In others, even this domain does not include Irish-speaking networks.

1.2 The Language Challenges

The main language and community development challenges are

1.2 Na Dúshlán Forbartha Teanga

Siad na príomhdhúshláin teanga agus forbartha pobail atá ann ná:

- (i) tacaíocht a thabhairt do thuismitheoirí Gaeltachta chun cur lena gcumas a gcuid leanáí a thógáil le Gaeilge;
- (ii) líon na gcainteoirí gníomhacha Gaeilge sa Ghaeltacht a chaomhnú agus a mhéadú;
- (iii) córas cuimsitheach pleinála teanga a fhorbairt ag leibhéal an phobail sa Ghaeltacht;
- (iv) stádas agus staid na Gaeilge a threisiú i gcliant-chomhlacthaí an Údaráis.

Tá an straitéis seo ag tabháirt aghaidh ar na dúshláin seo agus leanfar í le pleinanna breise gníomhaíochta cuimsitheacha diríthe ar threisiú na Gaeilge mar phríomhtheanga pobail na Gaeltachta a chur i bhfeidhm i gcomhar leis na pobail Ghaeltachta.

1.3 Geilleagar agus Infraestructúr na Gaeltachta

In ainneoin feabhsuite le blianta beaga anuas, tá bonneagar fisiciúil agus teileachumarsáide formhór na gceantar Gaeltachta fós easnamhach. Tá dúshlán níos mó ná riamh ag baint le hinfheistiocht a mhealladh agus le fiontair dhúchasacha a bhunú agus a fhorbairt de bharr na n-easnamh sa bonneagar. Cuireann na heasnaimh seo isteach freisin ar chaighdeán saoil pobail agus ar a rochtain ar sheirbhísí.

Is sna cathracha atá an chuid is mó den infheistiocht i gcomhlacthaí seirbhísé intrádála, idirnáisiúnta eolas-bhunaithe agus is beag ceantar Gaeltachta ná tuaithe atá ábalta dul in iomaíocht don chineál seo tionscnamh mar gheall ar na heasnaimh sa bonneagar fisiciúil agus teileachumarsáide. Teastaíonn feabhas mór ar chaighdeán an bonneagair agus tá gá ar leith le leathanbhanda ardluais chomh maith le hinfraestructúr eile. Tá sé seo riachtanach má tá na fiontair sheirbhísé atá mar dhlúthchuid d'eacnamaíocht an eolais le giniúint go háitiúil nó le mealladh chun na Gaeltachta in éadan iomaíocht ghéar ó cheantair níos forbartha sa tir.

- (i) supporting and empowering future generations of young Gaeltacht parents to raise their children through Irish;
- (ii) maintaining and increasing the proportion of active Irish speakers in Gaeltacht areas;
- (iii) the development of a comprehensive language planning system at community level in the Gaeltacht;
- (iv) the strengthening of the status and state of the Irish language in Údarás client companies.

1.3 Gaeltacht Economy and Infrastructure

This strategy addresses these challenges and will be followed by comprehensive action plans aimed at strengthening the Irish language as the main community language in the Gaeltacht, which will be implemented in conjunction with Gaeltacht communities.

Despite improvements in recent years, the physical and telecommunications infrastructure in most Gaeltacht areas remains deficient. Infrastructural deficits make it more challenging

to attract inward investment and promote the start-up and development of indigenous enterprises. They also affect the general quality of life of communities and their access to services.

Most of the investment in internationally-trading knowledge-based services companies is currently taking place in cities and it is difficult for many Gaeltacht areas to compete for these projects due to their deficient physical and telecommunications infrastructure. Radical enhancement of the quality of the infrastructure is needed and there is a particular requirement for high-speed broadband access if the new service-based enterprises that typify the knowledge economy are to be stimulated and attracted in the face of more intense competition from more developed areas in the country.

The economic environment has changed radically leading to the contraction of services, both commercial and public, in many rural areas and to increased pressure on enterprises. Access to high-quality third-level education in the Gaeltacht as well as access to artistic life has become a key issue for many. These form a key quality-of-life expectation for all communities.

De bharr na mbrúnna eacnamaíochta sa tír faoi láthair tá cúngú á dhéanamh ar sheirbhís tráchtala agus poiblí in go leor ceantair tuaithe. Is ionchais caighdeán saoil do gach pobal iad rochtain ar oideachas tríú-leibhéal d'ardchaighdeán, mar aon le rochtain ar shaol na n-ealaíon.

Caithfear aird a thabhairt ar na hathruithe suntasacha sa timpeallacht shocheacnamaíoch agus freisin sa chomhthéacs buiséadachta ina bhfuil an tÚdarás ag feidhmiú agus sinn ag diríú ar an bpróiseas casta dúshláinach a bhaineann le forbairt eacnamaíochta imharthana sa Ghaeltacht.

1.4 Na Dúshláin Fhorbartha Eacnamaíochta

Tá meath suntasach tagtha ar ghníomhaiochtaí eacnamaíochta agus deiseanna fostaiochta i réimse leathan earnálacha. Tá tionchar mór ag an laghdú atá tagtha sa déantúsaíocht traidisiúnta, a bhíodh lárnach do chlár forbartha tionscail an Údaráis, mar aon leis an mbrú

breise ón titim shuntasach atá tagtha ar thionscal na tógála, ar bhonn fostaiochta na Gaeltachta.

Teastaíonn earnáil fiontair atá cruthaitheach, láidir, fuinniúil agus a bhfuil ar a chumas dul san iomaíocht san eacnamaíochta iomaíoch domhanda, le gur féidir deiseanna fostaiochta imharthana a chur ar fáil do phobal na Gaeltachta.

Ach an oiread leis an chuid eile den téarma, tá titim siar ar chumas iomaíochta na Gaeltachta i ndéantúsaíocht bheislúacha íseal, mar go bhfuil infheistíocht na hearnála sin athraithe chuig láithreacha íseal-chostais i dtiortha eile. Mar sin féin, tá, agus beidh, an déantúsaíocht mar pháirt thábhachtach den earnáil fiontraíochta agus den bhonn fostaiochta sa Ghaeltacht i gcónai.

Mar nach féidir brath ar dhéantúsaíocht chun na riachtanais fostaiochta ina n-ionláine a chomhlíonadh, caithfidh straitéis fiontraíochta an Údaráis diríú ar mhealladh agus ar forbairt comhlachtaí seirbhísí intrádála idirnáisiúnta eolas-bhunaithe agus ar an gcumas fiontraíochta a bhaineann le hearnálacha na mara, na turasóireachta, na teangeolaíochta agus le hearnálacha eile acmhainn-bhunaithe a spreagadh.

Recent significant changes in the socio-economic environment and also in the budgetary context in which An tÚdarás na Gaeltachta operates must inform and shape our approach to the sustainable development of the Gaeltacht.

1.4 The Development Challenges

There has been a substantial downturn in economic activity and employment opportunities across a range of sectors. The decline of the traditional manufacturing sector which had been central to An tÚdarás' industrial development programme coupled with the additional pressure from the fall off in the construction industry has had a substantial impact on the labour base of the Gaeltacht.

The creation of sustainable employment opportunities for Gaeltacht communities requires a strong, dynamic and creative enterprise sector capable of competing in an increasingly-competitive global economy.

As is the case for Ireland generally, the Gaeltacht is no longer competitive in low added-value manufacturing, which is being lost to lower-cost locations elsewhere. Nevertheless,

manufacturing is, and will continue to be, an important component of the enterprise sector and the employment base in the Gaeltacht.

As manufacturing can no longer be relied upon to meet job-creation requirements in full, An tÚdarás's enterprise strategy will also need to focus on attracting and developing internationally-trading knowledge-based services companies and exploiting the enterprise potential in marine, tourism and other natural resource-based sectors.

International competition for inward investment is growing more intense and has eroded some of Ireland's competitive advantage. Under these conditions, An tÚdarás' enterprise strategy places more emphasis on stimulating greater levels of entrepreneurship and promoting the start-up and growth of high-potential and indigenous companies.

This requires innovative approaches to tapping the enterprise potential of the Gaeltacht's natural and cultural heritage, including the stimulation of enterprises based on language, music and the arts. As a development organisation, we will use our knowledge and contacts in industry and markets to connect Gaeltacht enterprises with trade and investment opportunities both within and outside the Gaeltacht. We will work to stimulate economic

Leanfaimid orainn ag cuidiú le soláthar timpeallacht thacúil d'fhorbairt inbhuanaithe eacnamaiochta agus cultúrtha trí ghréasáin agus páirtnéireachtaí comhoibritheacha le geallsealbhóiri eile.

2.0 Dearcadh Straitéiseach i dtreo 2013

Tá dhá bhunphrionsabal sa straitéis seo, An Ghaeilge agus Forbairt Fiontraíochta. Tá na prionsabail seo ag croílár straitéise atá tiomanta dár raison d'etre, sé sin pobal agus eacnamaíocht fhuinniúil, rathúil, inbhuanaithe Gaeltachta a forbairt agus tríd sin áit na Gaeilge mar phríomhtheanga pobail na Gaeltachta a chintiú.

Tá roinnt dúshlán i ndán don Ghaeltacht i dtimpeallacht atá ag síor-athrú, dúshlán teangeolaíocha agus eacnamaíocha, mar atá amhlaidh sa chuid eile den thír. Is é an dúshlán teanga don Stát agus don Údarás ná a léiriú gur féidir an creimeadh teanga sa Gaeltacht a stopadh agus athghabháil a dhéanamh ar an teanga i lónraí pobail agus tógáil ar na hiarrachtaí seo.

2.1 An Ghaeilge

Foilsíodh Straitéis 20 Bliain don Ghaeilge 2010 – 2030 i mí na Nollag 2010. Cuimsíonn sí freagra an Rialtais ar an Staidéar Cuimsitheach Teangeolaíochta ar Úsáid na Gaeilge sa Ghaeltacht agus ní hamhán go ndeimhníonn sí ról reatha Gaeltachta an Údarás ach leagann amach ról nua don Údarás i gcur i bhfeidhm na Straitéis sa Ghaeltacht.

2.0 Strategic Vision towards 2013

Two over-arching principles underpin and guide this strategy, namely, An Ghaeilge and Enterprise Development. These principles inform our approach to delivering a strategy which is motivated and driven by our raison d'être, that of developing a vibrant, sustainable Gaeltacht economy and community, thereby maintaining Irish as the primary spoken language of the Gaeltacht.

In a rapidly changing environment the Gaeltacht faces a number of challenges – linguistic and economic, as is the case in Ireland generally. The language challenge for the State and for An tÚdarás is to demonstrate that the language erosion can be halted and that lost ground within community networks can be recaptured and built upon.

2.1 An Ghaeilge

A 20-year Strategy for the Irish Language 2010 – 2030 was published in December 2010. This strategy encapsulates the Government's answer to the Comprehensive Linguistic Study on the Use of Irish in the Gaeltacht and not only confirms the current Gaeltacht role of An

2.2 Cothú na Fiontraíochta

Our integrated approach to language support and promotion within the Gaeltacht will focus on the organisations being funded by us for this purpose, including Comhar Naónraí na Gaeltachta Teo., Muintearas, the community-based organisations, the Language Services Centres and university education through Irish. Through a language planning process and by strengthening and revitalising community networks, both language and community will thrive. In mobilising the organisations and client companies supported by An tÚdarás to develop and implement language support frameworks, we are confident that the number of language-based enterprises will substantially increase and the language will be strengthened as the main community language in the Gaeltacht.

2.2 Fostering Enterprise

In recent years we have shifted our strategic direction from one of quantitative growth to that of qualitative and sustainable development. An tÚdarás’ enterprise strategy will continue to focus on attracting and developing internationally-trading knowledge-based services companies and exploiting the enterprise potential in marine, tourism and other environmentally resource-based sectors. Our enterprise strategy will also place further emphasis on stimulating greater levels of entrepreneurship and promoting the start-up and growth of high-potential, innovative, indigenous companies.

Heretofore our pioneering approach to tapping the enterprise potential of the Gaeltacht’s natural and cultural heritage, including the stimulation of enterprises based on language, the natural environment, the arts and other heritage and cultural resources has led to the evolution of a growing creative economy within the Gaeltacht.

The current financial and economic climate will test our capacity to utilise these skills and we are confident that Údarás na Gaeltachta through this Strategy will provide the Gaeltacht

with the mechanisms to face the challenges ahead. Furthermore our strategy is consistent with the increased emphasis on concept of the “Smart Economy” which was published by the Government in December 2008. An tÚdarás will proactively utilise this policy in order to deliver competitive, responsive and effective programmes and services, appropriate to our Gaeltacht communities and clients.

Innovation – encouraging the discovery, research and development of new and innovative concepts at organisational, business and community development levels.

Sustainability – promoting and supporting balanced development in order to enrich the unique human culture and physical environment of the Gaeltacht.

Value – demonstrating efficient and effective use of financial and human resources

Collaboration – developing partnerships, alliances and networks which enable coordinated efforts to improve the quality of the work and social environment for Gaeltacht communities.

3.2 Foundation of this Strategy

It is stated Government policy to maintain and develop the Irish language. This strategy provides an integrated approach and policies to support, encourage, stimulate and strengthen the language and culture of the Gaeltacht.

This Strategy sets out a range of policies which will enhance the use of Irish as the primary community language in the Gaeltacht. Collaborative action at all levels will be harnessed

3.2 Bunchloch na Straitéis seo

6. Work in conjunction with other Irish language interests operating in the Gaeltacht to increase the weight of advocacy on behalf of the Gaeltacht and the Irish language, both locally and nationally.
7. Empowering Gaeltacht communities to optimise and develop their resources.

3. Provide appropriate support for existing and prospective clients.
4. Drive innovation by developing structured links and alignment between industry, academic institutions and other appropriate agencies in selected niche areas.

5. Accelerate economic growth through enhanced management and leadership capability within enterprise by developing and rolling out an integrated set of activities to improve productivity, innovation and competitiveness, including support mechanisms and training
6. Work alongside High Potential Enterprises (HPEs) to develop supports targeted at increasing 'value added' and gaining competitive advantage in niche sectors.
